<p>Leon County PUD Concept Plans are accepted most every Wednesday at the Leon County Development Support and Environmental Management Office. As a prerequisite, the applicant is required to obtain a Permitted Use Verification noting eligibility. Subsequently, the applicant shall complete a pre-application meeting and an application review meeting prior to submitting the final PUD application for DRC review. Subsequent to the DRC recommendation, the DRC will place the application on the next available Planning Commission and Board of County Commissioners agendas. DRC meetings are held every 1st and 3rd Wednesday. Applications for pre-submittal, application review and DRC are due two weeks prior to a scheduled meeting.
